Committee Reports- None.


Meeting adjourned at 6:45pm.



Millard A. "Bud" Baxley: Gunnery Sargeant Bud Baxley served in the US Marine Corps from January 1957-December 1979. He was sent to numerous duty stations, including San Diego, California, Iwakuni, Japan, Okinawa,



the Philippines, Camp Pendelton, California, 29 Palms, California, Vietnam (66-67), and New York City Recruiting Duty. Bud served in a variety of ways, including Radio Telegraph Operator, Radio Chief, Fire Directions Chief, various instructor

duties, and USMC Recruiter in NYC. He was awarded the Purple Heart, Navy Commendation Medal with Valor, the Combat Action Medal, the Good Conduct Medal, the Navy Unit Commendation Medal, the Presidential Unit Medal, the Vietnam Service Medal, the Vietnam Presidential Award, the USMC Recruiting Medal, the USMC Expeditionary Medal, the Naval Sea Services Medal, the National Defense Medal, and the USMC Reserve Medal.

After 22 years of exemplary service, Bud worked for Ford Aerospace, Texas Industries, and as a Texas Concealed - Handgun Instructor. He was married to his first wife for 62 years, and has 4 children, 7 grandchildren, and 8 great grandchildren. He has now been remarried for one year, and enjoys spending time with his family, his church, target shooting, and reading military history.

Bud was referred for a Quilt of Valor by Kathy Gause.

Sharon McDonald Clark: SP4 Sharon Clark served in the Women's Army Corps from August 1972-August 1975. Stationed at Campzama, Japan, Yongsan, Korea, and Camp Carroll Army Depot in Korea, she worked as a Data Communications Terminal Specialist. She was the first woman to graduate from the 8th US Army NCO Academy. She was given awards for Soldier of the Month and Soldier of the Quarter.



After her 3-year service career, Sharon attended university and received a Bachelor's Degree. She is married and has one son. She spent many years working in the Telecommunications field and later as a Landman in the oil and gas industries.

Sharon was referred for a Quilt of Valor by Michelle Lewis.



Victor Covarrubias: Staff Sargeant Victor Covarrubias served in the US Army from June 2001-March 2010. Stationed at Ft. Hood, Texas, Hohenfels, Germany, Camp Monteith, Kosovo, Ft. Lewis, Washington, and Ft. Salerno, Afghanistan, he worked as a

Human Intelligence Collector. He was awarded the Army Commendation, the Combat Action Badge, and the Schutzenschnur Badge, a prestigious badge for superior marksmanship.

After his 9 years of military service, Victor obtained a Bachelor of Science degree from Texas Women's University in Nursing. He married in 2016 and has two boys. He likes to play chess, go mountain biking, and go camping. Victor was referred for a Quilt of Valor by Melissa Barron.

Sandra D. Kelly: Captain Sandra Kelly served in the US Air Force from 12 September 1984-30 November 1996. Stationed at Andrews AFB in Maryland, Scott AFB in Illinois, HIckham AFB in Hawaii, and Robins AFB in Georgia, she worked as a Logistics Plans Officer, a Transportation Officer, and as Acquisitions Logistics Officer. Awards received included the Air Force Achievement Medal, the Air Force Commendation Medal, the Meritorious Medal,



the National Defense Medal, the Air Force Long Tour Ribbon, the Air Force Outstanding Unit award, and the Air Force Organizational Excellence award.

After her 12-year service career, Sandra settled in Grapevine TX. She has 3 children, 2 girls and one son, and while they were young, she was a substitute teacher, worked in the office of her church, and taught preschool. For the past 15 years, she has been employed in the medical field, working in office administration.

Sandra was referred for a Quilt of Valor by Stephani Allen.

Edward L. Miles, Jr: Petty Officer 3rd Class Ed Miles served in the US Navy from October 22, 1963-October 20, 1967. He served on the USS Hector AR-7, the Great Lakes Naval Training Center Electricians Mate School, the USS Albany CG-10, and the USS Corry DD-817, as an Electricians Mate 3rd Class. He was awarded the Navy Unit Commendation, the Navy Good Conduct Medal, the National Defense Service Medal, the Honorable Discharge Button, and the - Honorable Reserve Discharge Button.



After 4 years of military service, Ed worked for the US Postal Service as an electronic technician. He has

been married for 50 years, has one daughter and 3 grandchildren.

Ed was referred for a Quilt of Valor by Linda Krucky.

Devecchio Turner: E-5 Devecchio Turner served in the US Navy from July 1995-April 2003. He served as an Aviation Electronics Technician at the Naval Air Station-Joint Reserve Base at both New Orleans, Louisianna, and Ft. Worth, Texas. He served for 8 years with distinction during Operation Enduring Freedom and Operation Iraqi
