

Bear Creek Quilt Guild
Board Zoom Meeting Minutes
May 4, 2022

President, Kathi Runyan opened the meeting at 6:30 pm on ZOOM with the following officers and members present: Kathi Runyan, Kay Thomas, Kyle Mills, Kathy Longo, JoAnne Sheppard, Aleta Mayrose, and Michelle Lewis.
