Paula Burda. Long Time Member Bear Creek Quilt Guild

BC: Why did you join the guild and what did you expect to gain from it?

Paula: In 1993, I had just moved to Keller, and knew that a quilt guild would be a good place to meet people who were fun and creative.

BC: Have your goals in joining been met?

Paula: YES!

BC: What is your favorite style of quilt/quilting and has it changed throughout the years?

Paula: I am pretty open minded, when it comes to quilting. I like all styles. I like hand quilted, and machine quilted quilts. I don't do much appliqué. I like piecing but my favorite part is cutting, I love to cut fabric.

BC: Name one singular event or project from your time as a guild member that has pleased you the most.

Paula: This is an impossible question for me to answer, as I have had some great experiences.

BC: Who is most inspirational to you in your quilting?

Paula: That has to be Eleanor Burns. I started watching her shows when we lived in Kansas. She was the only quilter that was on TV at the time. I got to meet her in Houston many years ago, and she is as special in person as she was on TV.

BC: Do you have a favorite quilting tool or pattern that you rely on? What is it?

Paula: Y'all know I love scissors.

BC: Have you held any positions in the guild and what were they?

Paula: Yes I have been president, vice president, quilt show Co-chair and held many Committee chairperson positions.

Some fun and special facts about Eleanor Burns!

She was born on July 3, 1945! While we don't know Eleanor Burns birth time, we do know her mother gave birth to her on a Tuesday. People born on a Tuesday have great willpower and a lot of energy. In general, they are very ambitious. *Sure rings true!*

Burns first started stitching on her Aunt Edna's feed sacks. Her first book, *Make a Quilt in a Day: Log Cabin Pattern* was self-published in 1978. The book has been credited with starting a quilt-making revolution as people learned Burns's style of stitching a quilt.

She has since written more than 100 books on the subject of **quilting**. In addition, Burns has written many patterns and developed a series of specialty rulers for quilting.

The *Quilt in a Day* TV series, which first aired in 1990, was based on Burns' book *Make a Quilt in a Day*. You can still catch her today on YouTube demonstrating her Quilt in a Day techniques among many others.

- #1. **Page one** of the directory will have the updated officers and committee members as stated in the current BCQG newsletter for 2021.
- #2. **Page 2** will have the updated speakers for the 2021 year.
- #3. **Page 3** correction will be made addressing the typo in first paragraph after heading of Activities – “guild.”
- #4. **Page 3** – under Membership benefits – 1st paragraph -- change “the benefits include” to “the benefits may include” -- 2nd paragraph - remove in its entirety.
- #5. **Page 4** -- 1st paragraph – “along with the immediate Past-President” will be changed to “along with a Past President.”
- #6. **Page 4** – 2nd paragraph – it will be changed to read ... “appoints all Standing Committees (which includes Audit and Nominating committees), other committee chairs, and serves as...”
- #7. **Page 5** – Under communications: “...updates Facebook page, and conducts the zoom meetings for the guild when required.”
- #8. **Page 6** – Remove the Quilt Show Boutique and Quilt Show Mini... paragraphs...as these are not really committees. These would come under the discretion of the 2nd VP for Quilt Show.
- #9. **Page 7** – TAQG will be edited out.
- #10. **Page 8** – Remove the entire TAQG section.
Amend to the Retreat: A retreat is scheduled at least annually.
- #11. **Page 9** – Add to the bottom of page:
“All donated items for JPS and Cooks Children’s should be laundered prior to turning them in to Community Service.”
- #12. **Page 10** – Add Susie Emmons with the dates 12/19 – 12/20
- #13. **Page 28** – Delete Keller, TX from heading.
- #14. **Page 29** – Article VI, Section 1: “The elected officers, and a Past President, will be...”
- #15. **Page 29** – Article VI, Section 2: ... “with the exception of the Treasurer, whose term ends at the conclusion of the annual audit in January.”
- #16. **Page 31** – Section F. “The Past President: (The outgoing President may become the current Past President for the New Executive Board. If unable or unwilling, this position may also be filled by a former Past President.)” Continue with #1 and #2 under the duties...
- #17. **Page 31** – Article VIII. Section 1: change **the** Past President to “**a**” Past President.
- #18. **Page 33: #9** on page – Member Instructed Workshops: **add the:**

#19. Page 34: Under #11: **Take out** the reference of Quilt Show Boutique, Quilt Show Mini Quilt Silent Auction, and TAQG. **Add in** Audit and Nominating Committees.

#20. Page 34: Add #13 – remove the last half sentence from #12 and add to 13:

13. All receipts for reimbursement must be submitted to the Treasurer in a timely manner (max. 60 days) and must be accompanied by a completed and signed “Request for Payment” form.

#20. Page 35:

“Quilting Bees are informal groups sewing together on a regularly scheduled basis. Bee members may work on their own **or group** (machine and/or hand) projects. The size of each bee is limited /determined by space at their meeting location. Bee members are also encouraged to become members of Bear Creek Quilt Guild. Contact person should be a member of Bear Creek Quilt Guild.”

#21. Page 35: New info for Beekeeper will be here. List of Bees will be different. Info will be given from the beekeeper.

#22. Page 5 and 6: We need to add the Audit and Nominating committees to the Committees and Duties pages. (These will be added in alpha order.)

Here is what is proposed:

Audit Committee: Audits and gives an updated report of the guild financial transactions after the final bank statement is received by the Treasurer. The committee will consist of a member from the Executive Board and two guild members in good standing with BCQG. This committee is appointed by the current President. This committee meets in January.

Nominating Committee: Nominates the Executive Board members for the upcoming year. The Nominating committee will consist of one current Executive Board member and two guild members in good standing with BCQG. This committee is appointed by the current President. The committee starts meeting in August of the current year. Nominations will be completed by October of the current year with mention at the guild meeting and roster of candidates placed in the October newsletter. The guild membership votes on the new Executive Board roster in November. The new board will then be installed in December and begin their new positions at the conclusion of the December meeting.

February 2, 2021, BCQG Board Meeting Minutes Zoom Meeting

President, Kathi Runyan opened the meeting at 6:32 pm on ZOOM with the following officers and members present: Kathi Runyan, Nancy Carr, Aleta Mayrose, Kay Thomas, Kyle Mills, Kathy Longo, JoAnne Sheppard, Susan Turk, Sheri Jones, Pam Roark, Mary Nalley, and Vicky Kidd. Michelle Lewis, Debra Heid, and Beth Gerth were excused. Kathi welcomed everyone to the meeting. The previous meeting minutes were reviewed by board members. The motion to accept was made by Aleta Mayrose, seconded by Kyle Mills, and minutes were approved.

Treasurer's Report: Kyle Mills reported all signature cards were completed for the smooth transition of the office of Treasurer. She also reported expenses of \$616.20 (for speaker, Zoom, and misc. items), with a net loss of -\$616.20. Kathi R. received an insurance invoice for the guild and will scan to forward to Kyle for addressing.

1st VP Report: Aleta reported the Guild meeting's speaker for February 16, 2021, is Karen Stone with her Trunk Show presentation. Business meeting will begin at 7pm, with presentation to begin at 7:30pm. An email blast with more information will be distributed to members. March's program will be on Zoom featuring Patricia Smith and her lecture, "Precision Piecing." Planned for April is Amy Hurst as guest speaker giving her lecture on wool. If not restricted by COVID, a workshop may be planned. More information to follow.

2nd VP: Kay Thomas reported that she hasn't received specific information yet about a ZOOM meeting to be scheduled February 26, 2021, to discuss possible plans for the Quilt Show in Irving. She was made aware that a meeting may possibly be scheduled for that day. More to follow.

Unfinished Business:

Kathi reported that Past President, Nancy Carr, sent out collated and suggested revisions to the by-laws and policies to Executive Board members to review for discussion. Notations and changes were reviewed for presenting to the Guild membership for voting on in March. A motion to accept the proposed changes/additions for presenting to the Guild was made by Kyle Mills, seconded by Kay Thomas, and the motion passed. Information to be forwarded in the newsletter only.

New Business:

Guild Website—

Concern has been expressed regarding PII (personal information identifiers) in the Guild newsletter and on the BCQG website. There was much discussion surrounding how to manage this. It was mentioned that initially, when joining, members can opt out of having their personal information being published. It was suggested that the personal information could be removed from the back of the newsletter even though the newsletter is sent to members only, and regularly placed in the "members only" section on the website. Some members were okay with sharing their email and phone numbers. Those individuals who are not okay with sharing personal contact information, please let Kathi Runyan, JoAnne Sheppard, or Sheri Jones know.

The website developer invoice is due—for a one year commitment it costs \$250.00/year, and a five year commitment is \$1000.00 (with one year being free). The year runs from October to September. Concerns were raised as to current information managed by the developer that we need access to. Mary Nalley to investigate this further. After much discussion, a motion was made by Kathy Longo to maintain a one year contract and to revisit a 5-year contract next year, seconded by Nancy Carr, and the motion passed.

Use of Guild ZOOM account for Bee groups—A reservation form has been established for the use of the BCQG ZOOM account for Bee group get-togethers, sew-ins, or meetings. Requests are first come, first serve and to be requested for each individual occurrence, at least one day in advance to JoAnne Sheppard. The requesting contact must be a BCQG member. President, Kathi Runyan, opened the meeting and welcomed everyone at 7:02 pm on ZOOM. The January 2021 guild member meeting minutes were reviewed and a motion to accept was made by Colleen Connor, seconded by Pat Clancy, and minutes were approved.

Treasurer's Report: Kyle Mills reported no income for January, with a net of -\$616.20.

2nd VP Report: Kay Thomas has received no information regarding the Guild Quilt Show.

Past President: Nancy Carr reported that By-Laws and Policies recommendations from Board need to be reviewed by members. Kathi Runyan to report on. Nancy also reported no scholarship applications have been received.

Unfinished Business: Kathi Runyan reported that the Guild Board had reviewed changes/updates to the by-laws and policies at the February Board meeting and collated a list to share with members. For membership to review these changes/updates, they will be included in the February newsletter. All members are encouraged to attend the March 2, 2021, Board meeting at 6:30pm, to voice any concerns/changes/amendments to the proposal. At the next guild member meeting on March 16, 2021, the updates will be voted on by the membership.

New Business:

Personal Identifying Information (PII): Members who have a concern with their personal identifying information being included in the current newsletter format have until March 25, 2021, to notify either Kathi Runyan, JoAnne Sheppard, or Sheri Jones to have it removed. Most of the PII is located in the members only section of the website, however, the current newsletter is always available to the general public. If you are uncomfortable with your email or phone number being available to the public, you must notify one of the individuals aforementioned so changes can be made to the newsletter. If you do not, the information will continue to be included. The guild is moving to a format utilizing the info@bearcreekquiltguild.com email address for questions, information, and communication.

Website update and maintenance: The Board voted to renew the BCQG website consultant for one year, as opposed to a five year offer, at the cost of \$250.00. The five year commitment included one year free, however, the Board decided to review this plan at the next renewal date in September 2021.

Guild ZOOM account: Kathi Runyan reported the Guild had purchased a ZOOM account subscription for one year and will be making it available to all guild members for Bee meetings and sewing connections. Interested members need to contact JoAnne Sheppard with their requests and a completed form for each instance of use. No recurring meetings will be scheduled, and usage will be scheduled on a first come, first serve basis. Forms are available on the website.

Committee Reports

Community Service: Debra Heid reported she had dropped off some quilts to JPS Hospital and they were happy with them. She has encouraged more donations going forward. JPS has also requested donations of phone chargers for patient use.

Quilt Boutique: Kayleen Allen reported that if we have a quilt show, she is requesting items for the boutique. Please let her know what you can do to help.

Retreats: Chairperson, Susan Turk, reported on upcoming retreat at Sunset Retreat, for April 8-April 11, 2021. Currently, 15 members have signed up to attend.
